MSC ORDINARY MEMBERSHIP

INFORMATION FOR CLUBS

Each Season a MSC Ordinary Membership Form **must be filled out and submitted to the MSC Secretary** for each Club Member that has paid their Club Fees (Over 18 Years of Age) to their own MSC Sporting Club (e.g. MCC, MFNC, MSFC) so they can be properly registered as a Ordinary MSC Member.

ANNUAL FEES

If a MFNC, MCC or MSFC paid up Member (e.g. Player, Committee Member, Club Member) has paid their Annual Club fees they are considered to have paid their Annual MSC Membership Fees. However **they still must fill out the MSC Membership Form to become registered as a Ordinary Member.**

If a person has not paid a Club Membership Fee they still can officially join the MSC as an Ordinary Member if:

- They fill out the Official MSC Membership Form
- Get two (2) Current MSC Ordinary or Life Members to fill out & sign the nomination Section of the MSC form
- Pay the Annual Membership Fee*:

**If the person is introduced through one of our Club's then the MSC Annual Fee can be paid to and retained by the introducing Club e.g. MCC or MFNC, or MSFC.*

If that person is an active Office Bearer or Role holder for the introducing club then they only have to pay a **Nominal \$20 Annual fee for their 12 month membership. (Again these fees may be retained by the club concerned.)*

**If that person does not hold a formal role for a Club then they still can be nominated and receive MSC Membership if they pay a \$50 Annual Fee, again if they are introduced by a member MSC Club like MFNC then that Club may retain the fees.*
